	<p>MO: By having in plain view and within reach a glass pipe with burnt marijuana residue inside of it.</p> <p>Lt. Warner, Sir,</p> <p>On November 17, 2008, at approximately 0118 hours, PTL. GREEAR and I were dispatched to 1614 Lakewood on a noise complaint. I listened at the door and could hear several voices loudly talking and the base beat of a stereo.</p> <p>I knocked on the door. A male yelled from inside, "If you ain't got fucking business, Don't knock!" The male, later identified as ARA/JORDAN A. BITZER, then swung open the door. BITZER was standing off to the side and looking at us. Directly in front of us was a wooden coffee table with a glass marijuana pipe. The smell of the marijuana was overpowering and smoke was still hanging in the air. I asked BITZER where the weed was and he stated, "It's all gone now."</p> <p>I told BITZER we were here on a noise complaint. BITZER admitted that his voice travels. BITZER was asked who's pipe it was and BITZER stated it was his. BITZER was issued citation #M41772 for paraphernalia and released. The pipe was collected as evidence, tagged into evidence, and placed in the LPD property vault. BITZER was advised of the noise complaint.</p>
