Topic Original Report

M.O.: By providing the incorrect date of birth during the course of an investigation.  
 M.O.: By being voluntarily intoxicated, causing a risk of harm to himself and/or others.

On 11/19/08, at 0243 Hrs, Officer Mullen and I responded to 1655 Waterbury regarding two males fighting. When we arrived on scene, I spoke with COM/ROBERT LIRSH. LIRSH indicated his roommate was involved in an altercation with a house guest, and felt it was escalating. LIRSH walked us into the residence.

OIV/EDWARD PUGH and ARA/ANDREW BENSON were standing in the kitchen. When I asked them to come speak with us they complied. PUGH indicated ANDREW was a guest of his, and stated they just had a few beers tonight and argued. As ANDREW stood in the living room, he was swaying back and forth. ANDREW had a moderate odor of an alcoholic beverage on his person, had glassy and half opened eyes, had slurred speech and was unsteady on his feet. When I asked ANDREW for identification, he indicated he did not have any. ANDREW provided his name, social security number, and the date of birth 6/7/87. When I asked ANDREW his age, he stated he was 22. When I confronted ANDREW with the fact he could not be 22 with the DOB provided, he insisted he was 22 again, and provided the same DOB.

PUGH and LIRSH stated they did not want ANDREW at the residence this evening. ANDREW was placed in handcuffs and was secured in vehicle #207. I transported ANDREW to the station where he was booked by C.O. McCarthy for DCI. ANDREW again provided 6/7/87 as his DOB at the booking window. We were unable to confirm ANDREW's DOB at this time.

On 11/19/08, at approximately 0530 Hrs, When I contacted the phone number provided by ANDREW at the booking window, OIV/CHERYL BENSON answered the phone. CHERYL identified herself as ANDREWS mother. CHERYL indicated ANDREWS actual date of birth is
