N A R R A T I V E 1	Topic Original Report	<p>M.O. By being in possession of 5.7grams of marijuana and admitting to be under the influence of such drug.</p> <p>On 11-21-08 while working at Lakewood High School I was called to the Health office about two students who might be under the influence of narcotics. Upon arrival I met OIV/JOHN CRANE, ARJ/ , and ARJ/</p> <p>I was advised that the two students came late to class and their teacher, OIV/CHRISTOPHER PHILLIPS, smelled an odor of marijuana on them. Upon observation both girls pupils were dilated which is consistent with an individual high on drugs. Both girls were asked if they had been smoking and they denied it. CRANE searched 'S book bag and found a gold colored box which contained green leafy-like substances believed to be marijuana. It also contained a "blunt" which is a rolled up cigarette that contained burnt marijuana. and admitted to CRANE they left school and went to Parkwood to smoke the marijuana. The girls said they were walking down the street when smoking.</p> <p>S legal guardian, OIV/EUNICE ALEXANDER, came to the school and picked her up. We could not get a hold of S parents but her aunt, OIV/EVELYN HERNANDEZ, was at home and said she would let her parents know. EVELYN didn't have a car so I transported home. EVELYN eventually got a hold of 'S mother who was on her way home when I dropped her off.</p> <p>The marijuana and blunt was confiscated, weighed at 5.7 grams, and tagged. It tested positive for marijuana with the Narc Kit Jr. It was placed down the secured property room drug chute.</p>
