

Topic Original Report

On 11/22/08, at 1815 Hrs., officers were detailed to 18500 Detroit (Riverwood Cafe) on a call from COM/ROSS M. ALFANO stating he was assaulted. In route to the scene dispatch advised that ROSS M. was now at his residence at 18865 Detroit. He advised dispatch he thought the people who assaulted him may still be at the bar. INV. MALLOY and I went to the Riverwood and spoke with the bartender OIV/CHRISTINA ROKAKIS. She stated she witnessed the fight but advised that the parties involved had left prior to our arrival. ROKAKIS stated she was familiar with ROSS M. because he is a regular patron of the business. She stated there was only one other male involved. ROKAKIS said she did not know the other male. ROKAKIS stated the bar was not very crowded at the time of the fight. She said she heard and observed the altercation.

ROKAKIS stated that ROSS M. was "hitting on" the female that male was with. She stated male advised ROSS M. several times to leave female alone. ROKAKIS stated that ROSS M. pushed the male and put his arm around the female. ROKAKIS stated that the male punched ROSS M. in the face knocking him to the floor. She said ROSS M. got up and left the bar. ROKAKIS stated that the male and the female left shortly after the incident. ROKAKIS described the male as a white male in his twenties with dark hair.

I responded to ROSS M.'S residence to speak with him. PO. O'BROCK was already on scene speaking with ROSS M. and his father OIV/ROSS C. ALFANO. ROSS M. stated that he was in the bar with ROSS C. when was approached by a male. He said the male attempted to start a fight with him. ROSS M. stated the male called him a "bitch" and asked him if he wanted to get "fucked up". ROSS M. stated he and ROSS C. left the bar and were "jumped" by the male and another male. He said the two males knocked him down and punched him and kicked him several time. He said they ran E/B on Detroit. ROSS M. stated he had never seen the males before. He described them as white males. ROSS M. had visible bumps to the right and the left side of his head. ROSS M. provided a written statement to PO. O'BROCK. He stated he did not desire medical attention. He said he desired prosecution if the males were located. I spoke with ROSS C. and he stated that ROSS M. was "sucker punched". He stated he did not know what else went on between ROSS M. and the male.

It should be noted that ROKAKIS and ROSS C. both stated the fight occurred inside the bar contradicting ROSS M.'S statement. ROKAKIS and ROSS C. also both only mentioned one male hitting ROSS M. It should also be noted that I could detect a moderate odor of a alcoholic beverage coming from ROSS M.'S person. His speech was also slightly slurred. ROSS C. had no signs of intoxication. I took photos of his injuries.

ON 11-22-08 AT APPROXIMATELY 5:00 PM I WENT TO THE RIVERWOOD CAFE WITH MY FATHER. WE WERE AT THE BAR DRINKING FOR ABOUT AN HOUR WHEN AN UNKNOWN MALE CAME UP TO ME AND SAID, WHAT ARE YOU A TIGHT GUY. I DIDN'T RESPOND AND THE MALE SAID, YOU WANT TO GET FUCHED UP, WHAT ARE YOU A BITCH. AGAIN I DIDN'T RESPOND TO HIM. MY FATHER AND I THEN WALKED OUT OF THE BAR THROUGH THE SIDE DOOR ENTRANCE ONTO RIVERSIDE. AS SOON AS I EXITED THE BAR I WAS JUMPED BY TWO UNKNOWN MALES. I WAS KNOCKED TO THE GROUND. WHEN I WAS ON THE GROUND I WAS PUNCHED AND KICKED APPROXIMATELY 30 TIMES IN THE FACE BY BOTH MALES. ONE OF THE MALES SAID DON'T FUCH WITH ME PUNK AND THEN BOTH MALES RAN FROM THE SCENE EAST BOUND ON DETROIT. I THEN WALKED BACK TO MY RESIDENCE WITH MY FATHER. AT MY RESIDENCE I THEN CALLED THE POLICE.
