	<p>On this date VIC/BENJAMIN KROFT came to the front counter to report he was robbed last night, 12/03/08, between 2320hrs. and 2340hrs. KROFT was walking Southbound on Lakewood, approaching Franklin, when he was approached by three black males, all about 5'8 to 5'10, thin build, black hoodies, and jeans. KROFT thought the suspects came from the row of houses on the Southeast corner of Lakewood and Franklin. KROFT could not provide any further description of the males but believes they all live at 1553 Lakewood. KROFT thought he has seen the suspects enter and leave this address before. KROFT walked past the three males when one of the males walked in front of him and put a weapon to his head. The other two males reached into KROFT's pockets and removed his wallet with his driver's license and social security card inside. One of the males told KROFT "Get the fuck out of here before I blast". KROFT ran Northbound on Lakewood and returned home. KROFT was on the way to Sams Beverage before he was approached by the males.</p> <p>KROFT had no visible injuries and could not explain why he did not report this incident last night. KROFT was unsure if he could positively identify the suspects again if he saw them. I asked KROFT if this was a drug related transaction that did not go well and he stated that it was not. KROFT thought the weapon used was a .50 caliber Desert Eagle but was not sure, and could not provide any additional information on the weapon.</p>
