Topic Original Report

MO- By having a clear plastic baggie containing 1.0G of marijuana in the left front pocket of his jeans

On 12/10/2008, at approximately 2055hrs, I was traveling Westbound on CANNON approaching WEBB. I observed a party in jeans and a hooded sweatshirt about to cross Northbound from the Southeast corner of CANNON and WEBB. As I neared the corner, the male abruptly turned Southbound. I had been detailed to assist PTL. D. MCCARTHY on a traffic stop, and as I left the area Eastbound on NORTHWOOD, I observed the party still walking Southbound, but crossing over to the West side of WEBB.

I was called off from assisting on PTL. MCCARTHY's stop, so I turned around at DETROIT and BONNIEVIEW to attempt to locate the male. I felt it unusual that he abruptly headed in the opposite direction as I approached the intersection of CANNON and WEBB in LPD marked unit 218. I located the male walking Westbound on the North sidewalk of DETROIT, just East of WEST CLIFTON. I notified Dispatch of the stop.

I asked the male for identification and he told me he did not have any on him. He was informed of the reason for the stop. He expressed his belief he had done nothing wrong, and added that he had just moved to the area. I asked the male for consent to search his person, and he would not allow me to do so. The male kept placing his hands into the front pockets of his hooded sweatshirt. The male was instructed to keep his hands out of his pockets. He placed his hands back in the pockets again, so I informed him that I was going to pat him down for my safety.

When checking the male's left front jeans pocket, I felt an object that my training and experience led me to immediately recognize as a baggie of marijuana. I did not remove the drugs at this time as I was by myself and had not positively identified the male yet. I decided to wait until I had another officer with me to confront the male about the marijuana.

The male verbally identified himself as (ARA)HOREY. I asked where he was heading to, and he replied home. When asked where he was coming from, he told me a friend's house. I asked where this was, and he hesitated and then told me Nelson.

PTL. LEANZA arrived on-scene to assist. At that time, I removed the baggie of marijuana and advised HOREY he was under arrest for Drug Abuse. He was secured in handcuffs at this time. Note that HOREY had a pocket knife in his right front pocket, but it was of legal size. No other drugs were located on his person during a search incident to arrest.

I advised HOREY that I was going to cite and release him, so I removed the handcuffs. He was issued Citation #M42305 and advised of his court date.

I transported the baggie of marijuana to LPD. There I used a Narkit Jr test kit and obtained a positive test result for marijuana. The marijuana was weighed, then tagged and placed in a clear evidence bag before being placed down the drug chute in the property room.
