Topic Original Report

On 9/11/08 John Dimassa filed an application change for his liquor permit at The Flying Rib. Dimassa is now the sole owner of the stock in the bar and will be the only one listed on the new permit.

As of 12/31/08 the bar is closed for remodeling and will reopen sometime before St. Patrick's Day. I spoke with Dimassa who wants to reopen the bar as soon as possible but thinks it will take at least two months for repairs and remodeling.

As of 12/31/08 Dimassa is the only employee of the bar. Dimassa does not have a CCH.

A history search of calls was done through CAD and the liquor file.

The only liquor violation since Dimassa took over ownership of the bar in 2001 was in September of 2007 when the bartender sold beer to underage patrons.

For the year of 2008 LPD was called to the bar 12 times.
