
Topic Original Report

MO/ By knowingly having in his possession and item commonly used to ingest narcotics To Wit; 1- multi-colored glass pipe with burnt residue.

On 01-17-09 the listed vehicle was stopped for faulty exhaust at Plover and Lark. The driver of the vehicle was identified as the owner (OWN) MEINCKE, KARL, he was advised for the reason of the stop. The front seat passenger was identified as (ARA) MAYHUGH, MATTHEW and the back seat passenger was identified as (SUB) SEIDOWSKI, JAMES.

In checking the parties though the computer it was found that SEIDOWSKI had an active warrant with Lakewood PD for contempt of court. SEIDOWSKI was removed from the vehicle handcuffed and secured in car 217. A search of the vehicle was completed incident to arrest. In searching the vehicle, I located the listed marijuana pipe underneath the front passenger seat. MAYHUGH admitted that the pipe belonged to him.

MAYHUGH was issued citation M41864 for Drug Paraphernalia and released at the scene. SEIDOWSKI was transported to the station where he was booked for his warrant. The marijuana pipe was then tagged and placed down the chute located in LPD's secured property room.
