	<p>At Bobby O's, PO Maurer, PO Hayes and I spoke to COM/PATRICK CARLIN and OIV/JOHNATHAN FILLAR. PATRICK stated he may have been struck in the face during the fight, but could not be positive. PATRICK had no visible injuries. PATRICK refused medical treatment and did not desire prosecution. JOHNATHAN had a small cut on the bridge of his nose. JOHNATHAN did not know his nose was cut and could not say how it happened. JOHNATHAN refused medical treatment and did not desire prosecution. Both PATRICK and JOHNATHAN stated the fight began over a sports game which was showing on the television at Bobby O's.</p> <p>MARK stated the following: MARK was at Bobby O's with JEFFREY and SHAWN when a fight started between JOHNATHAN and JEFFREY over the game. JEFFREY was struck in the mouth by JOHNATHAN. MARK left Bobby O's with JEFFREY and SHAWN. JOHNATHAN's son MICHAEL followed after them from Bobby O's. Police then arrived. JEFFREY's mouth was bleeding slightly. JEFFREY refused medical attention and did not desire prosecution.</p>
