Topic Original Report

MO: By being in possession of the listed small baggie containing Marijuana.

On 1/20/09, at 2011 Hrs., I was on patrol in the area of Cranford and Clifton. I performed a random registration check of the vehicle in front of me, the listed 1997 Ford Probe. The listed owner, OWN/BRIAN FIGAS's, driver's license came back suspended. I pulled alongside of the vehicle to get a better look at the driver. The male driving appeared to match the physical description of BRIAN. I initiated a traffic stop and this officer stopped the vehicle on Lakeland just south of Clifton. I advised the driver of the reason for the stop. He identified himself as ARA/MICHAEL FIGAS, BRIAN's brother.

Immediately, I could detect a odor of fresh Marijuana coming from the vehicle. I asked MICHAEL if there was any marijuana in the vehicle. MICHAEL stated there was not. The passenger in the car, identified as ARAYOUCEF BELAMRI, stated he had smoked Marijuana prior to getting into the car. I looked closer into the car and observed a small plastic baggie, which appeared to contain marijuana, in plain view on the center console to the right of MICHAEL's right arm.

PTL. HARNER arrived to assist and MICHAEL was asked to exit the vehicle. I retrieved the bag from the vehicle. I asked MICHAEL about the bag and he stated it was his. MICHAEL further stated that he had purchased the marijuana in Cleveland earlier today. I asked BELAMRI to exit the vehicle. I asked him if he had any contraband on his person. BELAMRI stated he had a bag of marijuana in one of his pockets. I checked his pockets but did not locate any marijuana. BELAMRI then stated he threw it out the window after he saw me pull up next to them. I searched BELAMRI further and located a bag of marijuana in his right shoe. BELAMRI stated he was dishonest about throwing the marijuana out because he was nervous.

MICHAEL was issued misdemeanor citation #M42754 for Drug Abuse and traffic citation #D166481 for No Seat Belt. BELAMRI was issued citation #M427755 Drug Abuse. I tested the marijuana with a Narc-kit and it field-tested positive. I weighed and tagged the marijuana and placed it down the drug chute in the property room. The bag that belonged to Michael weighed 2 grams. The bag I located in BELAMRI's shoe weighed 17 grams.
